

## **Refund Policy for Woolf Institute Online Courses**

This document sets out the Refund Policy of the Woolf Institute ("Institute") related to the following Online Courses ("Course" or "Courses"):

## Please read this refund policy before applying for the courses as noted above.

- I.I Where notice of cancellation is received II or more working days before the start of the Course, the Applicant will be eligible for a refund of any fees paid minus the Administrative Fee. Any outstanding fees must be paid to the Institute.
- 1.2 Where notice of cancellation is received between 6 and 10 working days before the start of the Course, the Applicant will be eligible for a 50% refund of the fees to cover costs incurred. Any outstanding fees must be paid to the Institute.
- 1.3 Where notice of cancellation is received 5 or fewer working days before the start of the Course, the Applicant will be eligible for a 40% refund of the fees to cover costs incurred. Any outstanding fees must be paid to the Institute.
- I.4 Where notice of cancellation is received during the Induction Week or Week I of Module I of the Course, the Applicant will be eligible for a 30% refund of the fees to cover costs incurred. Any outstanding fees must be paid to the Institute.
- I.5 Where notice of cancellation is received after two weeks of the start date of the Course [i.e. after Induction Week <u>AND</u> Week I of Module I], the Applicant will not be eligible for a refund. Any outstanding fees outstanding must be paid to the Institute.
- I.6 All refunds will **only** be made to the Applicant or, e.g., their Employer who paid the fee. Refunds will not be made in cash. If payment was made by bank transfer, the Applicant or,



e.g., their Employer, will be contacted and asked to provide relevant bank transfer details. All refunds will be calculated in UK Pounds Sterling. The Institute will not refund any shortfalls due to fluctuating exchange rates nor will it offer compensation for any bank or other charges incurred.

1.7 If, for any reason, the Institute cancels a course, fees paid will be returned in full.
